

MEDICAL REQUIREMENTS

IF POSSIBLE, PLEASE BRING COMPLETED FORMS TO SCHOOL REGISTRATION.

****Parents of students entering Pre-School, Kindergarten, Sixth, Ninth, and Twelfth Grade (or school for the first time)** are reminded that student physical examinations and/or up-to-date immunizations **MUST** be completed PRIOR to October 15th. Additionally, all junior high and high school students wishing to compete on any interscholastic athletic team are required to have an up-to-date physical exam on file.

Physical examinations must have been completed within one year to the date of entering those specified grades by a physician licensed to practice medicine in all its branches. ****Students will be EXCLUDED from school on OCTOBER 15th if proof of vaccinations or physical documents is not provided.**

*****Dental exams are due by May of the current school year. Vision exams for students entering Kindergarten are REQUIRED by October 15th. After that date, report cards can be held until the exam or proof of an exam is shown.**

New students entering Illinois schools for the first time must have a physical, up-to-date immunization records, eye exam and/or requirements for the grades listed above. Records of students transferring from other school districts within Illinois must also be checked for compliance.

****If prescription medication needs to be given while at school, new forms MUST be on file for the current school year or medications will NOT be given. Up-to-date forms for food allergies substitution, asthma action plans, and allergy & anaphylaxis emergency plans will also be needed, if these pertain to your child.****
